INTENDED AUDIENCE

FOREKNOWLEDGE

Basic level: Mainly covers theoretical concepts to provide a general overview (introduction).

CONTENT

The training course consists of two interactive modules in which theory, videos and exercises are combined.

Content

Module 1

The impact of the GDPR legislation on personal data:

- First we talk about **your privacy** in the Internet era. Do you remember which companies and websites have access to your private data?
- In the second part we zoom in on **GDPR**: what is this law about, and how does it protect personal data?
- Then we look at how personal data are **processed**, and what the processor should take into account.
- Finally we consider **the rights of an individual**: can you for example arrange to alter or even delete data?

Module 2

The impact of the GDPR directive on organisations and the responsibility of employees:

- First we study the **legal framework**: when are you allowed to process your data and how should you do that?
- In the second part we focus on **services and applications**: what do you have to take into account when developing a new product?
- After that, you learn more about how to **protect** your data against abuse, and which measures you should take if things go wrong nevertheless.
- Finally we see which persons and authorities play a role in the protection of your privacy. Who is **responsible** for the correct processing and who exercises **control** over this?

At the end of each module you will get a number of test questions. Passing this test (minimum rate 75%) entitles you to training points.
